**THE 94<sup>TH</sup> MEETING OF THE ASEAN COORDINATING COMMITTEE ON SERVICES (CCS) AND RELATED MEETINGS IN MANILA, 21-25TH OCTOBER 2019**



94<sup>th</sup> ASEAN Coordinating Committee on Services (CCS)



37<sup>th</sup> ASEAN Architect Council Meeting

The 94<sup>th</sup> CCS meeting in Manila, Philippines, were held back to back with the ASEAN Architecture Education Committee Meeting, ASEAN Architect Roundtable Meeting, ASEAN Architect Council (AAC) Meeting and Business Services Sector Working Group. LAM was represented by Ar. Zairul, president of LAM, Ar. Mustapha Salleh, a Board member and Ar. Yong Razidah Rashid, the Registrar.

During the ASEAN Architect Roundtable Meeting two papers were presented. The first paper presentation was Market Outlook of the Philippines which gave an overview of the Philippine Economy including the demand drivers and trends. The second paper presentation was The Trend of Construction Contracts and Architectural Practice in the Philippines which discussed about project delivery procurement and the evolution of delivery processes and methods. The AAC meeting was chaired by Brunei and attended by representatives from all ASEAN member states. The meeting discussed ideas in moving forward with the implementation of the MRA and means to promote more collaboration among practices in ASEAN. Delegates were then invited for a site visit to the city of Taal, in the province of Batangas which is famous for its old ancestral houses and its heritage buildings.



### GENERAL CIRCULAR NO. 2/2019

#### ARCHITECT'S NOTIFICATION AND CERTIFICATION FOR COMPLETION OF SUPER STRUCTURE STAGE IN A STRATIFIED DEVELOPMENT

This General Circular is issued to advise all Architects in their role as a Principal Submitting Person (PSP) in a stratified development, that they are required under the present regulations to certify the completion of super structure stage (SSS) prior to submission of application for subdivision of a building or land by a Licensed Land Surveyors.

1. In accordance with Section 8A(1) of the Strata Title Act 1985, the certification for completion of super structure stage is required to indicate the commencement of three months timeframe for the submission of application for subdivision of a building or land by a Licensed Land Surveyors.
2. Certification requirements under this Act are additional statutory obligations that Architects are obliged to comply. An architect appointed as a Principal Submitting Person (PSP) is to certify and make necessary declaration under the Act, and shall not unnecessarily refuse to comply with these requirements.
3. As per Section 4, Strata Title Act 1985 [Act 318], "super structure stage" means the stage upon the completion of building works as duly certified in accordance with the relevant by-laws made under the Street, Drainage and Building Act 1974 [Act 133].
4. Thus, it gives the meaning that "super structure stage" completion will trigger upon certification of Form G12 by the PSP upon completion of the building works, where the appointed Licensed Land Surveyor shall be duly notified on the issuance of form G12 and the three months timeframe for the submission of application for subdivision of a building or land shall then commenced.
5. However, to prevent delay in preparation of the submission of application for subdivision, PSP may progressively allow a Licensed Land Surveyor to carry out the strata survey by notice of completion of part of the building whenever it is physically completed and ready for the survey works as per the conditions stated in **Table 1**.
6. At any stage prior to final certification of SSS, the PSP may notify the Licensed Land Surveyor to carry out the survey on part of the building or land, provided that the site is ready for the survey.

**Table 1: Minimum completion requirement for commencement of strata survey works.**

Boundary (Building/Land)	<ul style="list-style-type: none"> <li>• Perimeter walls and fences are required to be constructed to ensure all buildings and structures are located within the lot;</li> <li>• External carpark (open space carpark), is marked prior to strata survey where the physical boundary is well identified;</li> <li>• Main structure of the parcels and common properties need to be ready with floor slab, wall and the underside of the structure above (soffit) are built to mark the parcel boundaries.</li> </ul>	<ul style="list-style-type: none"> <li>• Boundary verification survey will be carried out twice. First mobilisation will be setting out of boundary for construction of perimeter wall or fencing. Second mobilisation is for verification survey to check all structures are being constructed within the boundary.</li> </ul>
B. Parcel/Accessory Parcel	<ul style="list-style-type: none"> <li>• Permanent features and main structure of the parcels, accessory parcels and common properties need to be ready with floor slab, wall and the underside of the structure above (soffit) are built to mark the parcel boundaries; and</li> <li>• The parcels, accessory parcels and common properties shall be clear from any obstruction.</li> </ul>	
C. Common Property	<ul style="list-style-type: none"> <li>• Lift core must be built;</li> <li>• All guardhouse, lift lobbies and utility rooms (including TNB substation, pump rooms, chiller room, AHU rooms etc.) need to be ready with floor slab, wall and the underside of the structure above (soffit) are built to mark the boundaries; and</li> <li>• Sufficient lighting to be provided for the survey works.</li> </ul>	
D. Basement	<ul style="list-style-type: none"> <li>• Each car parking and motorcycle parking bay need to be marked whether it is an accessory parcel or a common property (including disabled and visitor car parks);</li> <li>• All parts of main basement structure either common properties or parcels need to be ready with floor slab, wall and the underside of the structure above (soffit) are built to mark the boundaries; and</li> <li>• Sufficient lighting to be provided for the survey works.</li> </ul>

7. All Licensed Land Surveyor, staff and their assistants are required to adhere to safety guidelines and statutory requirements while carrying out the survey.

#### PENGESAHAN DAN PENSIJILAN ARKITEK BAGI PENYIAPAN PERINGKAT STRUKTUR UTAMA DALAM PEMBANGUNAN BERSTRATA

Pekeling Am ini dikeluarkan untuk memberi nasihat kepada semua Arkitek mengenai peranan mereka sebagai Orang Utama Mengemukakan (PSP) dalam pembangunan berstrata, bawa di bawah peraturan semasa mereka dikehendaki untuk mengesahkan penyiapan 'peringkat struktur utama' (SSS) sebelum mengemukakan permohonan untuk pecah bahagi sesuatu bangunan atau tanah oleh Juruukur Tanah Berlesen.

- Selaras dengan Seksyen 8A (1) Akta Hakmilik Strata 1985, perakuan untuk penyiapan 'peringkat struktur utama' (SSS) adalah diperlukan untuk menunjukkan permulaan tempoh masa tiga bulan untuk mengemukakan permohonan pecah bahagi sesuatu bangunan atau tanah oleh Juruukur Tanah Berlesen.
- Keperluan perakuan di bawah Akta ini adalah tanggungjawab berkanan tambahan yang perlu dipatuhi oleh Arkitek. Seorang arkitek yang dilantik sebagai Orang Utama Mengemukakan (PSP) perlu memperakui dan membuat pengisyian yang perlu di bawah Akta ini, dan tidak boleh secara tidak wajar enggan mematuhi keperluan ini.
- Seperti dalam Seksyen 4, Akta Hakmilik Strata 1985 [Akta 318], 'peringkat struktur utama' bermaksud peringkat apabila selesai kerja-kerja bangunan yang disahkan selaras dengan undang-undang kecil yang berkaitan di bawah Akta Jalan, Parit dan Bangunan 1974 [Akta 133].
- Oleh itu, ia membawa maksud bahawa penyiapan 'peringkat struktur utama' akan bermula apabila perakuan Borang G12 dibuat oleh PSP setelah selesai kerja-kerja bangunan, di mana Juruukur Tanah Berlesen yang dilantik akan dimaklumkan sewajarnya mengenai perakuan borang G12 dan tempoh masa selama tiga bulan untuk penyerahan permohonan untuk pecah bahagi sesuatu bangunan atau tanah dengan itu akan bermula.
- Walau bagaimanapun, untuk mengelakkan kelewat dalam penyediaan pengemukaan permohonan pecah bahagi, PSP boleh secara berperingkat membenarkan Juruukur Tanah Berlesen untuk menjalankan pengukuran strata melalui notis bagi penyiapan bahagian bangunan yang telah siap secara fizikal dan telah sedia untuk kerja-kerja pengukuran mengikut syarat-syarat yang dinyatakan dalam **Jadual 1**.
