## OBJECTIVE

To confer an award to a deserving Architect and/or Interior Designers who has contributed by conduct, action and achievement to the profession, building industry as well as society, and in so doing enhance the standing of Architects/Interior Designers and the profession in society

## CRITERIA

The following but not limited to:

- Character of Nominee
  - Dignity, Leadership Quality, Integrity, Loyalty to colleagues and profession, Humility, Dedication
- Contributions to the Profession
  - Education, Practice, Legislation
- Contributions to the Building Industry
  - Interpersonal
- Contributions to Society
  - By action and/or patronage has contributed to society e.g. charities, NGOs and national/international recognition

## ELIGIBILITY

- At the time of nomination, the nominee must be an Architect and/or Interior Designer and has not received the award previously. A nominee who has been nominated but not awarded in a particular year may be re-nominated in subsequent years.

## NOMINATION PROCEDURE

- Nominations will be invited from Architects/Interior Designers through LAM's official media. Each nomination must be made in a form of a letter addressed to the President of LAM by at least two (2) Registered Architects/ Interior Designers.

Nominations must include the following:

- Nominee's name and career biography, including evidence of the nominee's work in accordance with the selection criteria, with consent from the nominee; and
- A brief write up of why the nominee deserved the Award and list of major contributions to the advancement of Architecture/ Interior Design (not less than 200 words in A4 size)

A juror who is unavailable may be replaced by another suitable person nominated by LAM provided the Jury maintain the composition as stated above.
